- A security deposit (per line): 150€
- The security deposit is requested at the time-of-service activation. It is returned upon termination of the subscription contract after regular payment of the last invoice. VAT is not charged on the Security Deposit.
- Pricing: first minute full rate then in fractions of 15 seconds
- Minimum term period depends on the plan. Once the minimum term has been completed, from the activation date, the contract will continue on month-to-month basis
- If the service is deactivated before completion of the minimum term, will be applied an ETF (Early Termination Fee) the equivalent of the months to complete the minimum term will be charged
